

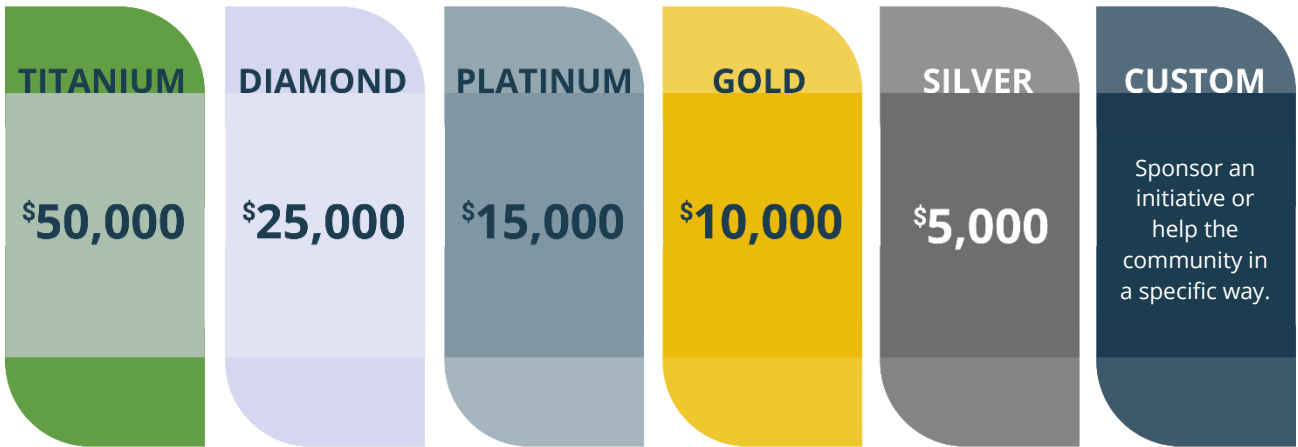

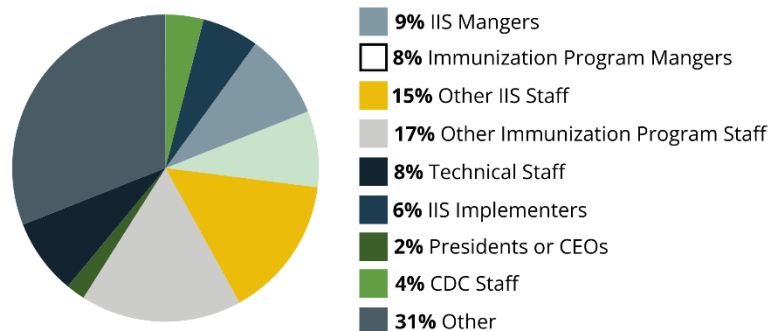

FAQs ABOUT AIRA

What is AIRA?

The American Immunization Registry Association (AIRA) is a membership organization that exists to support and promote **the development and implementation of immunization information systems (IIS)** as a crucial tool in preventing and controlling vaccine-preventable diseases.

How does AIRA serve the IIS community?

AIRA provides a forum through which members combine efforts, share knowledge, and promote activities to advance IIS and immunization programs. **AIRA is a resource for a strong, unified voice for standards, policy and funding, data exchange standards development, information sharing, and education/training for IIS managers and staff.**

Who are AIRA's members?

AIRA's members are **IIS staff working in health departments, IIS implementers, and nonprofit organizations** such as community advocacy and education coalitions. AIRA members also work with our **Corporate Partners**, who are for-profit organizations committed to AIRA's mission. Currently, there are more than 1,000 members of AIRA representing over 106 organizations.

How do members participate in AIRA's efforts?
