### **Using Outside Data Sources to Update Patient Records in the NDIIS**

The North Dakota immunization program submitted client record data to the NAPHSIS Electronic Verification of Vital Events (EVVE) Fact of Death system and used address and name update information from the North Dakota Department of Transportation to update patient status and demographic data in the NDIIS.

### **Identifying Exposed Persons for Recruitment into the Flint Registry**

The Michigan Care Improvement Registry and other public health data sources were used to identify people who may have been exposed to elevated lead levels through the municipal water system. These data were deduplicated, linked, and ultimately used to inform and prioritize recruitment of persons into the Flint Registry for outreach.

### **Enhancing IIS to Assess Refugee Vaccination Coverage**

Colorado's Immunization Information System (CIIS) and Refugee Health Programs partnered to automate the entry of overseas refugee immunization records into the IIS and enhance IIS functionality to better accommodate refugee data. # Improving Immunization Rates Among Children & Pregnant Women on Medicaid

Disparities in vaccination coverage are significantly greater for pregnant women and children on Medicaid compared to those with private insurance. AcademyHealth, the National Academy for State Health Policy, and Immunize Colorado are overseeing a CDC initiative to identify barriers and opportunities to improve immunization among low-income pregnant women and children.

Over half of the respondents cited concerns about expanding access to new users or clinics, capturing vaccination data from nontraditional providers, rampup of onboarding activities, and decreased data quality. # System Requirements for IIS: A Resource for your Procurement, Planning, and Development Efforts

# Digital Immunization Registry in Pakistan: Insights from Big Data Analysis

The Zindagi Mehfooz Digital Immunization Registry (ZM-DIR) has been developed and implemented throughout Sindh, Pakistan. Covering a population of more than 48 million people, 2,236 vaccinators across 1,390 facilities have registered over 3 million children and over 20 million immunizations. ZM-DIR records real-time individual-level

child immunizations and has demonstrated an increase in immunization coverage and timeliness.
