AIRA was founded in 1999 after a nationwide measles outbreak from 1989 to 1991 that prompted the development of immunization registries in communities and regions across the country. Member Spotlight: Wisconsin

Wisconsin Immunization Registry AIRA has had a tremendous impact on the Wisconsin Immunization Registry (WIR), according to **MATTHEW VERDON**, WIR unit supervisor. "During my 17 years working with the Wisconsin Immunization Registry, AIRA has always been a seamless partner in the work we do. So seamless that, when pulling together my team recently to talk about how AIRA benefits us, nearly all were surprised just how widely AIRA positively impacts our work. Be it through participation in workgroups, webinars, and trainings or using the resources and tools, AIRA's impact is widespread." Newer and seasoned team members in Wisconsin agreed.

RACHEL HARVIEUX, WIR data deduplication specialist, is relatively new to IIS and public health. She has used countless AIRA resources in her training for her new role. "The AIRA resource repository has been a trusted resource for gathering background information specific to deduplication topics, helping to inform the redrafting of a manual, and procedural guidelines," Rachel said. "The AIRA Standards and Interoperability Steering Committee and HL7 User Group meetings often discuss topics immediately relevant to ongoing work and projects. These discussions have helped with problem solving and confident decision making."

According to **KEVIN SAMUELSON**, WIR implementation coordinator, AIRA has fostered important collaboration. "In my 13 years working around IIS, the collaboration between jurisdictions and other related entities (e.g., EHR vendors) has become more commonplace and has made for stronger relationships for the common good/goal of immunization management."

Member Spotlight: Illinois

AIRA has partnered with Illinois in significant ways. Senior epidemiologist **JANAE PRICE** said, "The Illinois Department of Public Health has been an AIRA member for over 15 years. The Immunization Section frequently uses tools provided by AIRA's Measurement and Improvement Initiative and user groups and trainings to improve (1) data quality and HL7 data sharing within our IIS, (2) provider onboarding, and (3) skills in data visualization using programs such as Power BI and Tableau."

In April 2023, AIRA launched a pilot project to help Illinois develop an interactive data visualization tool to display school vaccination coverage rates. According to Janae, "AIRA has been instrumental in helping the Illinois immunizations team gain quick hands-on training and 1:1 technical assistance related to working in Tableau. This has resulted in the development of the first of many Illinois public facing immunization dashboards. The team's understanding of Tableau and its various layouts and feature options has expanded significantly and pushed our team to consider more creative ways of sharing immunization data, not only internally but also to a myriad of different external audiences (e.g., parents, school admin, local health departments)."

Janae shared how AIRA's impact is widespread. "AIRA has played an instrumental role in standardizing data systems and processing across multiple IIS programs nationally. AIRA's discovery sessions and national meetings have provided Illinois with timely opportunities to network and collaborate with jurisdictions and programs facing similar challenges." Janae said, "We greatly appreciate AIRA's dedication to providing hands-on help and assistance with data modernization. The Illinois Immunization Section shares the desire for improved and transparent data systems that can not only respond to future pandemics but also use data for public health action."

Through education, advocacy, standards development, and the Measurement and Improvement (M&I) initiative, AIRA helps strengthen all IIS to ensure healthy communities.



What sets AIRA apart is the organization's deep commitment to **COLLABORATION**. AIRA has 1,018 active AIRA workgroup members, including 644 members from all IIS.

Advocacy and Partnerships

Advocacy work is one of the primary ways AIRA ensures IIS are supported and represented. With an overarching view of the IIS landscape, AIRA elevates IIS needs and concerns to a national stage, speaking as the collective voice for the IIS community.

By engaging stakeholders and partners at a national level, AIRA ensures IIS interests are championed and advanced. AIRA's strategic partnerships include various national organizations, as well as federal agencies.

Convening the Community

AIRA convenes the IIS community to foster collaboration, explore latest IIS best practices, and address key priorities for IIS.

Educational webinars provide training and education on key topics impacting the IIS community.

Newsletters, including AIRA's Weekly Update and quarterly SnapShots, highlight the progress, activities, and accomplishments of AIRA and IIS.

Regional workshops and **national meetings** advance the IIS community by providing professional education and training, developing new relationships, and strengthening long-term partnerships.

AIRA's **IMPACT** is expansive. Over 560 individuals from 132 organizations attended AIRA's Discovery Sessions in FY 2023.

Measurement and Improvement

Through the **Measurement and Improvement (M&I)** initiative, AIRA partners with individual IIS to identify opportunities for improvement and offers operational and technical assistance to help each IIS align with national standards to facilitate interoperability with other health care systems.

The M&I initiative provides all IIS with information and tools to more fully align with Functional Standards. The project connects IIS test systems with AIRA's testing web application called the Aggregate Analysis Reporting Tool (AART). Within AART, each IIS has access to customized quarterly reports on how that individual IIS is doing in specific content areas, such as data quality and forecasting. Through this process, AIRA helps jurisdictions institute standards and improve their systems.

By bringing the IIS community together under broadly implemented standards, all IIS gain **CREDIBILITY** and become increasingly **SUSTAINABLE**.



Measurement and Improvement

The M&I initiative's final step is validation. Validation acknowledges IIS that are progressing toward or achieving alignment with community-selected measures and tests. This public-facing approach showcases how IIS are meeting or exceeding community standards for interoperability, functionality, and quality.

Onboarding Shared Services Program

In collaboration with CDC, AIRA developed the Onboarding Shared Services program to support IIS in provider organization onboarding for immunization data exchange. The program uses the <u>Onboarding</u> <u>Consensus-Based Recommendations</u> for improving and standardizing onboarding and is designed to address several challenges including:

- Large queue of providers waiting to onboard
- Establishing or improving onboarding processes and/or documentation
- Staff training in provider onboarding and onboarding best practices

To address these needs, the onboarding program provides:

- <u>Standardized documentation</u> to support provider onboarding
- <u>Onboarding templates</u> that can be modified to meet jurisdictional needs
- Onboarding process consultation and development
- Live, instructor-led <u>onboarding training</u>

1,135 hours of onboarding technical assistance was provided to 16 jurisdictions across 27 TA tickets and 5 TA projects

Provider Organization Onboarding for IIS

AIRA's Provider Organization Onboarding for IIS Course was held for the second time in summer 2023.

The training helps IIS implement standardized onboarding processes and procedures. The course is a live, interactive, instructor-led training that dives into each step of the onboarding process and includes best practices and implementation considerations.

Education and Training

AIRA provides invaluable training opportunities for the IIS community, including Tableau and Power BI training for data visualization, the Provider Organization Onboarding for IIS Course, AART clinics, and the IIS Interoperability: Connecting Systems Course.

Data Visualization Training

AIRA hosted several trainings and user groups in FY 2023 to support data analysis, visualization, and reporting, including the **Tableau User Group** and **Power BI User Group**. These user groups bring the IIS community together to share how Tableau and Power BI can be used to achieve data visualization goals.

Address Cleansing

Smarty is an address cleansing and geocoding service, provided with CDC's support, to help improve IIS data quality. By using Smarty, jurisdictions can validate addresses against United States Postal Service data and obtain the most accurate address, a United States Core Data for Interoperability data element.

To date, over **2.1 billion** addresses have been cleansed with **49** signed partner agreements in place for the Smarty service.

Immunization Integration Program

The Immunization Integration Program (IIP) is a collaborative partnership among CDC, AIRA, the Health Information Management Systems Society (HIMSS), and expert consultants to improve immunization interoperability, information sharing, and management. The IIP strives to increase the quality and usage of immunization data through cross-sector collaboration and solution development, electronic health record (EHR) testing, and technical support.

- The **IIP's Testing and Recognition** initiative is a way for EHRs to be tested on immunization capabilities and to be recognized for their ability to exchange data with IIS.
- The IIP Collaborative brings together partners and creates a forum to develop recommendations and solutions to improve interoperability.

2023 IIP HIGHLIGHTS

IZ Gateway

The IZ Gateway provides a centralized technical infrastructure that facilitates the flow of immunization data from IIS to vaccine providers that operate in multiple cities and states and back, as well as from IIS to consumers. The IZ Gateway Project aims to address gaps in data exchange between immunization registries, providers, and patients to provide more complete and accurate immunization records.

Emerging Standards

AIRA has been using our rapid cycle process to gather input and develop guidance for several years. The process empowers a small group of engaged, invested partners from diverse organizations to develop guidance or recommendations over approximately 4 weeks.

In the spring of 2023, the process was used to generate and evaluate potential approaches to accelerate IIS-to-IIS connections through CDC's IZ Gateway. The workgroup generated 26 recommendations, which were reviewed by AIRA and small-group co-champions. A final list of 12 recommendations was created to move forward with evaluation and scoring, yielding a prioritized and well considered list of recommendations provided to CDC and its contractors.

In the coming year, AIRA will use this process to gather rapid and comprehensive input on additional emerging standards and technologies. We look forward to collaborating with the community to continually improve the exchange of immunization information.
