# American Immunization Registry Association (AIRA)

## Privacy Policy

*Last modified: January 2026*

### Introduction

The American Immunization Registry Association (AIRA), (“**Company**,” “**we**,” “**us**,” or “**our**”) respects your privacy and is committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit our websites including, without limitation, <https://www.immregistries.org/>, <https://sabbia.westus2.cloudapp.azure.com>, or <https://app.immregistries.org/> (collectively, our “**Websites**”), including any content, functionality and services offered by the Company on or through our Websites, such as the Resource Repository, the Aggregate Analysis Reporting Tool (AART), the Epidemiologist Shared Services (ESS) code library, and other services (our “**Services**”) as well as our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect:

- On our Websites.
- Through the Services.
- In communications, including email, text, and other electronic messages between you and us.
- Through mobile and desktop applications you download from our Websites, which provide browser and dedicated non-browser-based interaction between you and our Websites.
- When you interact with our advertising and applications on third-party websites and services if those applications or advertising include links to this policy.

This policy does not apply to information collected by:

- Us offline or through any other means, including on any other website operated by Company or any third party (including our affiliates and subsidiaries); or
- Any third party (including our affiliates and subsidiaries), including through any application or content (including advertising) that may link to or be accessible from or on our Websites.

Please read this policy carefully to understand our policies and practices regarding your Personal Information (defined below) and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Websites. By accessing or using our Websites, you agree to this privacy policy. This policy may change from time to time (see Changes to Our Privacy Policy). Your continued use of our Websites after we make changes is deemed to be acceptance of those changes, so please check the policy periodically for updates.

## Personal Information We Collect About You and How We Collect It

We collect Personal Information about you when you visit our Websites or access our Services. "Personal Information" is any information relating to a natural person who is, or can be, identified either directly or indirectly from such information and includes information such as a user's name, address, telephone number, email address, Internet activity (such as browsing history), payment information (when paying membership, sponsorship, or registration invoices) or other information directly linked to that person.

We collect this information in a variety of ways, including:

- Directly from you when you provide it to us.
- Automatically as you navigate through our Websites. Information collected automatically may include usage details, IP addresses, operating system, browser type, search queries, and information collected through cookies, web beacons, and other tracking technologies.
- From third parties, for example, membership information from our business partners.

## Personal Information You Provide to Us

We collect certain Personal Information which you provide to us, including:

- Information that you provide by filling in forms on our Websites. This includes information provided at the time of registering to use our Websites, subscribing to our Services, posting material, or requesting further services. We may also ask you for information when you report a problem with our Websites.
- Records and copies of your correspondence (including email addresses) if you contact us.
- Your responses to surveys that we might ask you to complete for research purposes.
- Details of transactions you carry out through our Websites. You may be required to provide financial information when paying membership, sponsorship, or registration invoices through our Websites.

- Your search queries on our Websites.

You also may provide information to be published or displayed (hereinafter, “**posted**”) on public areas of our Websites or transmitted to other users of our Websites or third parties (collectively, “**User Contributions**”). Your User Contributions are posted on and transmitted to others at your own risk. Although we limit access to certain pages, please be aware that no security measures are perfect or impenetrable. Additionally, we cannot control the actions of other users of our Websites with whom you may choose to share your User Contributions. Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons.

You are not required to provide Personal Information to us, but if you refuse to provide such information, we may not be able to register you for membership or provide you with certain Services.

## Personal Information We Collect Through Automatic Data Collection Technologies

As you navigate through and interact with our Websites, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

The technologies we use for this automatic data collection may include:

- **Cookies (or browser cookies).** A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting, you may be unable to access certain parts of our Websites. Unless you have effectively adjusted your browser setting so that it will refuse cookies, our system may issue cookies when you direct your browser to our Websites.
- **Flash Cookies.** Certain features of our Websites may use local stored objects (“Flash cookies”) to collect and store information about your preferences and navigation to, from, and on our Websites. Flash cookies are not managed by the same browser settings as are used for browser cookies. For information about managing your

privacy and security settings for Flash cookies, see Choices About How We Use and Disclose Your Personal Information below.

- **Web Beacons.** Pages of our Websites may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the Company, for example, to count users who have visited those pages and for other related statistics (for example, recording the popularity of certain content and verifying system and server integrity).

## How We Use Your Personal Information

We use Personal Information that we collect about you or that you provide to us in a variety of ways, including:

- To present our Websites and its contents to you.
- To provide you with information, products, or services that you request from us.
- To fulfill any other purpose for which you provide the information.
- To provide you with notices about your account, including expiration and renewal notices.
- To carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection.
- To notify you about changes to our Websites or any products or services we offer or provide through it.
- To allow you to participate in interactive features on our Websites.
- To improve our Websites and to deliver a better and more personalized service.
- In any other way we may describe when you provide the information.
- For any other purpose with your consent.

We may also use your Personal Information to contact you about goods and services that may be of interest to you. For more information, see Choices About How We Use and Disclose Your Personal Information.

We may also use aggregated or de-identified data that is not personally identifiable for any legally permissible purposes without restriction.

## Disclosure of Your Personal Information

We may disclose Personal Information that we collect, or you provide as described in this privacy policy:

- To our subsidiaries and affiliates.

- To contractors, service providers, and other third parties we use to support our business and who are bound by contractual obligations to keep Personal Information confidential and use it only for the purposes for which we disclose it to them.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Information held by us about our Websites users is among the assets transferred.
- To fulfill the purpose for which you provide the information.
- For any other purpose disclosed by us when you provide the information.
- With your consent.

We may also disclose your Personal Information:

- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce or apply our [terms of use](#) and other agreements, including for billing and collection purposes.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of us, our customers, or others.

We may also disclose to third parties aggregate or de-identified data that is not personally identifiable for any legally permissible purposes without restriction.

## Choices About How We Use and Disclose Your Personal Information

We strive to provide you with choices regarding the Personal Information you provide to us. We have created mechanisms to provide you with the following control over your information:

- **Tracking Technologies and Advertising.** You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. If you disable or refuse cookies, please note that some parts of our Websites may then be inaccessible or not function properly.

We do not control third parties' collection or use of your information to serve interest-based advertising. However, these third parties may provide you with ways to choose not to have your information collected or used in this way. For example, you can opt out of

receiving targeted ads from members of the Network Advertising Initiative (“**NAI**”) on the NAI’s [website](#).

AIRA currently does not respond to Do Not Track (“DNT”) signals that may be sent by some browsers, and therefore does not honor such signals at this time.

## Data Security

We have implemented measures designed to secure your Personal Information from accidental loss and from unauthorized access, use, alteration, and disclosure.

The safety and security of your Personal Information also depends on you. Where we have given you (or where you have chosen) a password for access to certain parts of our Websites, you are responsible for keeping this password confidential. We ask you not to share your password with anyone. We urge you to be careful about giving out information in public areas of our Websites like message boards. The information you share in public areas may be viewed by any user of our Websites.

Unfortunately, the transmission of information via the internet is not completely secure. Although we take efforts to protect your Personal Information, we cannot guarantee the security of your Personal Information transmitted to our Websites. Any transmission of Personal Information is at your own risk. We are not responsible for any circumvention of any privacy settings or security measures contained on our Websites.

## Consent to Communications

When you use our Websites, or send e-mails, messages, and other communications from your desktop or mobile device to us, you are communicating with us electronically. You consent to receive communications from us electronically. You agree that (a) all agreements and consents can be signed electronically and (b) all notices, disclosures, and other communications that we provide to you electronically satisfy any legal requirement that such notices and other communications be in writing. We may contact you by telephone, mail, or email to verify your account information or to assist you in completing the account registration process.

In addition, by providing your email address and/or mobile number, you are agreeing to be contacted by us or on our behalf at the email address and/or mobile number you have provided, including calls and text messages, to receive informational and service-related communications relating to our Websites and our Services. Message and data rates may apply to text message communications. **To stop receiving text messages from us, reply with the word STOP.** We may confirm your opt out by text message. If you subscribe to

Please note, that by withdrawing your consent, some Website features and certain Services may no longer be available to you.

**You may also unsubscribe from marketing emails by clicking the “unsubscribe” link in the email.**

We are committed to being compliant with the Controlling the Assault of Non-Solicited Pornography and Marketing Act (“**CAN-SPAM ACT**”) and the Telephone Consumer Protection Act (“**TCPA**”). Emails, newsletters, and text messages received from us are intended to fully comply with the CAN-SPAM ACT and the TCPA. ## Children Under the Age of 18

Except as provided below, our Websites are not intended for children under 18 years of age. No one under age 18 should provide any information to or on our Websites.
